Standard Operating Procedure (SOP) for Immunization of Dental Students, Faculty and Healthcare Workers in Dental Hospital Departments:

Objective: To establish guidelines for the immunization of dental students and healthcare workers in dental hospital departments, ensuring protection against vaccine-preventable diseases and promoting the health and safety of all personnel and patients.

4. Immunization Records Management:
