INTERNAL AUDIT COMMITTEE

Being an affiliated college of the KNRUHS, MRDCW is committed to its duty of delivering classroom teachings on the curriculum set by the university. With the aim to cover the syllabus each department approach to ask in the right earnest by preparing a departmental calendar of its own and all portions of the syllabus to members of the faculty. In addition to the classroom teachings each department has also to hold departmental seminar, class tests, internal examinations etc. Each department arranges remedial and tutorial classes for the advance learners as well as for the slow learners. The departments and the teachers make every effort to complete all these activities to the satisfaction of all concerned within the departmental calendar of activities set at the beginning of the session. The members of Internal Audit Committee (IAC) shall conduct internal audit (inter - departmental) of the institution, in academic matters decided by the IAC. A group of three members of IAC, as decided by the IAC Coordinator shall verify the details of a department, but a member from the department concerned shall not be a member in the internal audit group.

Roles :


- To ensure complete coverage of the prescribed syllabus.
- To enable the principal to take the necessary remedial measure.
- To ensure that the co-curricular activities of each department have gone in the way they were planned.
- To fix accountability.
- To let the departments to know that all their activities and initiatives are really appreciated.

Responsibilities:

The Committee will cover all academic aspects such as interpretation of the syllabus, completion of the syllabus, performance in theory and practical, group discussions, seminars. Infrastructure adequacy, laboratories, Sports facilities, library and ICT facilities, etc.

- The principal may include any other related academic matter for audit in the terms of reference, which feels desirable.
- The Committee should submit report to the principal within the specified time.
