- a) The proposed Dental College i.e, **Mallareddy Dental College for Women** is located in the proximity of Mallareddy Dental College for Women a Medical College recognized by MCI and has also obtained an undertaking from the said Medical College that it would facilitate training to the students of the proposed Dental College in the subjects of Medicine, Surgery and Allied Medical Sciences.
