The Institution / College is fully responsible to fulfil the norms and to maintain the same which includes infrastructure both physical and human resource, teaching faculty and clinical material, etc., throughout the academic year, as stipulated in regulations of Dental Council of India.

The number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management Quota as specified by the Dental Council of India / KNRUHS.
