Whereas in pursuance of the application of M/s. Mallareddy Dental College for Women & Hospital , Sy.No.126, Suraram 'X' Roads, Jeedimetla(V), Medchal District- 500055. Seeking renewal authorization under Bio-Medical Waste (Management & Handling) Rules, 1998, the R.O. Medchal (RR-II) has inspected the premises on 13-03-2023, and after careful scrutiny of application and verification report of inspecting Officer, this authorization for generation, Segregation and safe-disposal of Bio-Medical Waste is issued to of M/s. Mallareddy Dental College for Women & Hospital , Sy.No.126, Suraram 'X' Roads, Jeedimetla(V), Medchal District- 500055. Subject to the terms and conditions mentioned in the schedule A & schedule B of previous authorization.

Order. No.16 / TSPCB / BMWM / RR(RR-II) / 2015-(28) dated 19.03.2015 remain the same with the following additional conditions:-

1. The HCE should provide adequate fire protection equipment (such as smoke detectors, fire extinguishers, sand bucket, fire alarm, water sprinklers etc) at salient places within the HCEs even at Bio Medical Waste storage area, in accordance with fire safety regulations and the HCE should obtain certificate from fire department.
2. The HCE shall follow all the conditions stipulated by Central Pollution control Board (CPCB), wherever Sharp Blaster (needle blaster) is provided for treatment of Bio Medical Waster (BMW) Category no.4 (i.e. waste sharps), listed under schedule-I of Bio-Medical Waste (Management & Handling) Rules 1998 and amendments made thereof.

The Bio Medical Waste shall be disposed for treatment after disinfection and segregation to the following common Bio-Medical Waste Treatment Facility.
